

PRESIDENT'S REPORT

The 2007-2008 continued to see unprecedented growth in the East Pilbara. Housing construction continued relentlessly within the town of Newman as it tries to keep up with its ever increasing population. The Shire's venues and facilities continue to be well utilised.

Council elections took place in October 2007 and we welcomed four new Councillors into the fold; Kelvin Portland, Debbie Becker, Kate Edwards and Stephen Kiernan.

The airport redevelopment has continued into the 2007/2008 year. New car parks have been constructed, landscaping undertaken and the beginning of the construction of the new terminal. A new taxi way / apron was constructed to allow more planes to be at the airport at one time and further resealing. The staff house at the airport is nearing completion and will provide much needed accommodation for a Shire staff member and their family.

The Shire continues to work on the plan for the construction of the Newman Community Co-Location Centre. Land was acquired from BHP Billiton and plans are near completion and the tender for the construction of the building will go out early in the new financial year.

With the continued population growth practical issues also needed to be addressed and half a million dollars was expended on Liquid Waste disposal at the Newman Refuse Site and upgrading of the sewage system also occurred.

With the help from the BHP Billiton and the East Pilbara Sustainability Agreement the Shire purchased an inflatable cinema which has already been utilised well. Also under the sustainability agreement the greening of Newman began, with some wonderful results and further lighting at the Town Centre were installed.

As is the case every year much of the Shire's resources is spent of roads and plant & machinery for the upgrade of these roads.

The Martumili Artists program continues to grow and art work from this highly successful program was exhibited in over eight major exhibitions all over Australia in the 2007/2008 year - with many more already organised for the new year. The program has highlighted how successfully partnerships between federal, state & local governments together with corporations can work. This program provides cross cultural interaction within the East Pilbara - particularly at a local level - in a very positive way.

In closing I would like to take this opportunity to thank all the staff at the Shire and Councillors who have contributed so much over this past year and also to pass on my most sincere thanks to Allen Cooper, CEO, for his dedication and tireless efforts in working for the betterment of the entire Shire. I look forward to the 2008/2009 year being an equally productive year.

CHIEF EXECUTIVE OFFICER'S REPORT

Welcome to the Annual Report of the Shire of East Pilbara for the 2007/2008 financial year.

Again the Shire and the Pilbara region as a whole experienced a year of continued growth and challenges. Council undertook a significant review of the organisational structure which saw the creation of a fourth Directorate — being Community Engagement. All four Directors were employed in the first half of the financial year.

Landcorp matched the extension to the Light Industrial Area with a land release for residential land in East Newman. These blocks will be balloted out early in the 2008/2009 financial year.

The Shire undertook its annual telephone survey in November 2007 again with a satisfaction rate of greater than 80%. Thank you for all those who participated in the survey. The results of the survey are used in Shire planning including the Plan for the Future of the District.

The Newman Airport numbers continue to rise and much of the work programmed for the 2007/2008 year has been completed. This included a new apron and taxi way and the new terminal building was commenced. It is expected the new terminal building will be completed before the end of the 2008 year.

The Shire experienced a much higher rate of stability within its workforce with a turnover for the 2007/2008 year of approximately 35% compared to nearly 60% last year.

Major highlights of the year included:

- Further works to the Newman Airport
- Major plant upgrades including a loader and two graders

- Further works to the Newman Town Centre including shades and lighting
- Commencement of greening of Newman program
- Newman Aquatic Centre upgrades and improvements
- Purchase of an inflatable cinema
- IT system and wireless upgrade
- Acquisition of land for the Newman Community Co-Location Centre
- Community Amenity upgrades at both the refuse site and sewage plant
- Footpath works
- Sealing of the Radio Hill Access Road
- Art Spaces for the Martumili artists

I would also like to take this opportunity to acknowledge the support and commitment of all Councillors and the Shire staff throughout the year.

THE SHIRE

The Shire of East Pilbara has produced this Annual Report as an open and honest disclosure to Residents and Landowners of the Shire of East Pilbara community.

The report contains specific information for the 2007/2008 financial year as well as reports required to meet our statutory obligations.

The Annual Report is presented to Council and residents at Council's Annual Electors Meeting as early as possible after the completion of the audit report.

Shire of East Pilbara

The Shire of East Pilbara is the largest Shire in the world and is located in the Pilbara Region of Western Australia. It is made up of the townsites of Newman, Marble Bar, Nullagine and the Aboriginal Communities of Jigalong, Kiwirrkurra, Parngur, Punmu, Woodstock, Warralong and Kunawarritji.

History

The Shire was formed by the amalgamation of the Shires of Marble Bar and Nullagine in 1972. Upon the amalgamation the Shire became the largest Shire in the world comprising an area of over 371,696 square kilometres (larger than the state of Victoria). In 1982 the town of Newman, which now is home to the main administration office of the Shire, was changed from a closed mining town to a "normalised" town.



Marble Bar was originally part of the Bamboo Road Board prior to the formation of the Shires of Marble Bar and Nullagine and later East Pilbara. The Bamboo Road Board dates back to 1896. Council retains a sub office at Marble Bar and the works construction crew operates from that location. A small work force also operates at Nullagine.



The estimated population of the Shire is 10,000 with over 7,000 living in Newman. The Shire is rich in Aboriginal Culture, mining and pastoral activities and provides a significant part of the State and Federal wealth.

Structure


Council Organisation





Financial Services

Rates

Council rates were increased by approximately 3.5% in 2007/2008.

Rubbish rates and sewerage rates remained the same.

Library Services

The Shire of East Pilbara operates two libraries at Nullagine and Marble Bar and financially contributes over \$100,000 to the Newman Library, which is a joint venture with TAFE.

Administration

The Shire is required each year to review its Policies, Delegations, Authorisations, Code of Conduct, Freedom of Information Policy along with all other manuals relating to Council procedures. This review was conducted with minor recommendations and adjustments.

A large effort was put into producing the Shire's Plan for the Future of the District, sending out information and collating the results.

Records Management

The Shire of East Pilbara Records system is an extensive overhaul undergoing preparation for the introduction of an automated records system. As a part of this preparation, in the 2007/2008 financial year staff have been appointed and trained. In fact, many of the Shire of East Pilbara office staff have undergone training in the Synergy Computer System, and some also in the Records Information component of the Synergy System. This training will improve the overall processes and information management within the office and its ultimate collection and retrieval within the Records Office, and allowing those trained in the Records Management to begin the preparation for input of information in electronic format.

Following on from this training, all systems and hard copy records within the Records Office are being reviewed and audited to allow maximum integration of the filing systems and optimum management of all the information held. Various sections of the records information are being reassessed and refiled to create a more user friendly and coherent method of filing and retrieval.

As a part of this, all our property information files have been reorganised to produce a coordinated shelving system based upon the property assessment number. This will give us a unified system that will easily link all the information relating to a property together in a hard copy file. This hard copy record is backing the Synergy Automated System which Computer creates automated records system that tie across various functions and processes within the Shire. So whether a ratepayer is building a investing extension. house. in an maintaining a compliant swimming pool, paying the rates, or owning a dog, all this information is accessible on the property files, and placed in the system through the regular office processes.

Training of staff in the importance and interlinking of these processes, and their role in the development and ownership of the information records produced, is integral to the quality and integrity of the final records and information produced. must consciously be aware of their role in the process of creating records and also recognise that others must access the information that they place into the system. must be understandable retrievable by others not so familiar with the initial process. The quality of input and cross referencing of all information as it is placed into the system is, therefore, vital for retrieval at a later date. All new systems require ongoing training and refining and developing of new processes and this is part of the challenge for the coming year.

Ultimately, our records and information system is a service to the community and to all the members of staff. An efficient and effective information and retrieval system therefore reflects the quality of our service and this is a key to our role in the community. We strive, therefore, not only to provide accurate and timely information in a useable format, but also to act in compliance with Shire policy and the State Records Office requirements.

DEVELOPMENT AND REGULATORY SERVICES

Newman Administration Office and Council Chamber



The Newman Administration Offices and Council Chambers were completed in February 2007.

The Newman Council Chambers will be fitted with new furniture and fittings during the 2008-2009 financial year.

A wireless data system has been installed in the Council Chambers for internet access for Council meeting, training and presentations.

New Council Houses

During 2007 the Shire contracted Wideglide Construction for the construction of 2 attached grouped dwellings at 3 Warrambucca Crescent, 2 houses at Lot 500 Wilara Street and Kurra Street, and the construction a house at the Newman Airport.

During 2007/08 several Shire houses have been refurbished, with kitchen upgrades, new floor covering, painting and carports installed.

Marble Bar Heritage Trail



The Shire of East Pilbara with many partners (Lotterywest, Marble Bar Tourist Association, Pilbara Development Commission, Department of Transport and Regional Services) began the identification and development of the Marble Bar Heritage Trail.

The trail journeys around the Marble Bar Township as well as surrounding areas. This is a tremendous facility for the community of Marble Bar and the tourists visiting the hottest place in Australia.

Signage and promotional material such as brochures and maps were completed in December 2007, several information stands will provide history on the town.

Display shelters have been incorporated on the Heritage Trail Walk which provides visitors with shelter whilst being provided with local history of the Marble Bar townsite.

This has been well accepted by the local community and the tourists that visit the region.



Nullagine Lookout

The Nullagine Lookout was completed in October 2007, with the construction of picnic benches, barbeque facilities, and information display of the local region showing water holes. The project was supported by the Pilbara Development Commission in conjunction with the Shire of East Pilbara.

Additional works to the site being the installation of an ANZAC Day Memorial site which incorporates shade and seating are being planned for the next financial year subject to funding approval.

Newman Community Co-Location Centre

The Shire of East Pilbara is nearing completion of the final draft designs for the Newman Community Co-Location Centre to be located at Rogers Way, Newman.

Funding for this project has been sourced additionally from the following organisations;

- Pilbara Development Commission
- Department of Transport and Regional Services
- Lotterywest
- Department of Local Government and Regional Services
- BHP Billiton Iron Ore

The construction of the Newman Community Co-Location Centre is due to commence in the later half of 2008 and completion mid 2009, this is part of the Newman Town Centre Revitalisation to improving the infrastructure of service to the local community and encouraging businesses to gain and retain staff in the town of Newman.

The facility will be tenanted by not for profit community organisations.

Newman Recreation Centre Modifications



The designs are currently being finalised by Hillam Architects with the funding sourced from the following organisations,

- Pilbara Development Commission
- Department Housing and Works
- Department Sport and Recreation
- Department of Local Government and Regional Services
- BHP Billiton Sustainability Project

The new design for the facility will provide the centre with specialised areas for programs, and improvement to administrative areas. Other improvements include

- Childcare Services
- Fitness Centre
- Improved access throughout the centre
- Attractive entrance and foyer

Newman Airport Terminal

The Newman airport terminal is currently under construction and is due for completion late in 2008. The new terminal has become essential due to the increased number of flights and passengers to the region.



Building and Planning

Due to the regional mining developments in the Pilbara and influx of people to the region the planning and building applications have increased dramatically due to the shortage of housing and accommodation in the region and the up scaling of infrastructure projects.

Planning

The following development applications were approved in the 2007/2008 financial year:

Major projects in progress:

Newman Community Co-Location Centre (\$4M)

Expansion of Newman Power Station (\$8M)
Upgrade of Newman Hotel (\$1M)
Expansion of Kurra Village - Stages 4 and 5 (\$19M).

47 properties were amalgamated and the old houses demolished by BHP Billiton to accommodate 76 new houses for mining personnel.

Development of the recently released industrial sites in the new light industrial area (Shovelanna Street and Wonmunna Road) is progressing well.

Newman Aquatic Centre



The Newman Aquatic Centre upgrade has almost been completed with the installation of the water play ground, the flooring has been additionally installed with soft fall recommended by the Risk Assessors. The upgrade to the infant pool includes additional shade and shelters. The brightly colored facility is surely going to be a success for families utilising the facility in the future summer season.

The new fencing has been installed between the 50 meter pool and the children's area to assist in the supervision.

Works are in progress to install the hydrotherapy spa to assist people with injuries and disabilities with rehabilitation.

Funding for this project was received by BHP Billiton and the Pilbara Development Commission.

A major upgrade of the pool pumps, filters and pipe works has been planned for the end of 2008.

Marble Bar Entry Statements

The Marble Bar entry statements consist of 4 designs of regional heritage to the region. The project has been a huge success for the tourism in Marble Bar.



Radio Station

The local radio station 6NEW-FM has been relocated to the Newman Aquatic Centre and is nearing completion.

The new building has been purchased by BHP Billiton and the Shire of East Pilbara has provided the site. Works yet to be completed include services connections, entry path and landscaping.

It is hoped that the radio station will provide additional after hours security at the pool and assist in reducing vandalism.



The local radio station has a strong focus on Local and Regional Community Services and provides local residents and mine sites with local and regional news, public information, entertainment, local events and functions.

Ranger and Emergency Management



Rangers continue to work towards compliance using community contact, education and enforcement to achieve appropriate outcomes.

Animal control, parking and littering continues to take up a large percentage of Rangers time.

Increased traffic at the Newman Airport and generally around town has increased to parking problems.

Rangers contribute to improving Aboriginal health through Community visits to treat animals for diseases and parasites which may impact on the community.

The Emergency Management Committee (LEMC), regularly meet to develop plans for the Cyclone and Bushfire season. The management of all fires occurring outside a gazetted fire district is the responsibility of the Shire unless they occur on private property where the Shire may be called upon to assist in their extinguishment.

Nullagine Bush Fire Brigade liaising with Local Police continues to provide strong Emergency Management leadership in the town and are developing Emergency Management and incident response plans for the town and surrounding residents.

Rangers are involved in this process as they can provide a link in the response phase of any incident and are a resource to be used in the recovery phase of an incident. The Shire is responsible for the recovery of its local communities after any incident.



Environmental Health

There has been a significant growth in demand on the Shire's Environmental Health services this year. This has been in line with the growth of Newman and the proliferation of mining camps. These services include -

- The assessment, inspection and approval of on-site effluent disposal systems.
- A routine pool and drinking water sampling program.
- The inspection, testing and licensing of new swimming pools at mining camps and caravan parks.
- The routine sampling of the treated effluent water used to irrigate parks and gardens in Newman.

- Routine inspections of food premises and caravan parks throughout the Shire.
- The routine maintenance and testing of three flocks of sentinel chickens for Murray Valley Encephalitis. The regular testing of blood samples from these flocks is used to access the ongoing risk from mosquito borne diseases.

The next financial year is expected to see further growth in demand for Environmental Health services and changes to the Public Health & Food legislation.

COMMUNITY ENGAGEMENT



Recreation Services

The Newman Recreation Centre is a facility that attracts a wide range of the community. The facility includes a Fitness Gym with membership that is continually growing. The Fitness Centre upgrade was completed in October 2007 with the official opening in November 2007. Use of the Gym has grown dramatically over 2007-08 with over 15,200 people using the facilities.

The qualified Les Mills fitness instructors are running a variety of classes, including Step and Pump. There have been approximately 500 fitness classes and walking programmes offered over the course of the financial year.

The Centre has sporting competitions and activities for junior and seniors. Our Gymnastics group has a very large participation with several children competing at championships this year.

Futsal casual soccer has been successful with many players dropping in for a game along with Badminton and casual court basketball.

The Centre has meeting rooms, sports courts and a variety of equipment also available for hire at competitive prices for individuals and groups.

Newman Outside School Hours Care

The Newman Outside School Hours Care is a licensed programme catering for the needs of primary school children. programme, which runs out of the Shire's crèche, was licensed for 26 children a dav. Children were picked up from the two local schools; South Newman Primary School and Newman Primary School. Over the course of 2007-08 the number of children booked into the programme has been steadily growing. The programme has been revamped and new staff employed. result is an excellent programme offering children a diverse range of activities covering the Creative, Physical, Exploratory, Cognitive, Constructive, and Drama/Fantasy areas.

The Newman Crèche also provided an Active after School Care programme three times a week that was funded by the Australian Sport Commission.

Vacation Care

During the course of 2007-08, a Vacation Care programme was offered during School Holidays. The programme was licensed for 39 children a day. Like after school care, the vacation care programme offered a diverse range of activities during the day. The programme operated between the hours of 8.00am and 4.30pm weekdays. hiahliaht children The for was introduction of excursion. The twice weekly excursions took children to a number of fund places around Newman. The most popular included trips to the Airport, BHP Billiton minesite and the Aquatic Centre.

Crèche

The Shire of East Pilbara also operated a Crèche in the mornings for the classes being run out of the Recreation Centre. The crèche operated Monday to Friday 8.30am to 11.30am and on Saturdays from 8.30am to 12pm.



Aquatic Centres

The Newman Aquatic Centre, together with the Newman Recreation Centre, remain the

hub of sport and recreation activities within Patronage at the Newman the town. Aquatic Centre continues to be high, with a large percentage of the community making use of its facilities during the year. During the course of the 2007-08 year there was a 25% increase in patronage levels. Centre offered a range of activities during the season including swimming lessons, swim club, aqua fitness, school swim and survive days run by the Royal Life Saving Association, water play activities and inflatable activities. A highlight of the year was the Australia Day open day. A large percentage of the community took the opportunity to visit and use the facilities. Included in the festivities was the launch of the Shire of East Pilbara's Outdoor Cinema. a joint project with BHP Billiton under the Sustainability Partnership. In line with the nature of the event, episodes of Skippy were shown to the large crowd gathered to experience something new in Newman.

During the year, the swim school at the Newman Aquatic Centre continued to grow following its re-organisation the previous, year. Structured activities were also popular, with attendance at the Aqua-Aerobics/Water Fitness Classes high. Additionally, new events were run including a triathlon and the Rottnest Island Swim.

The upgrades to the pool are now almost completed, which ensures that the Newman Aquatic Centre remains a high quality facility - one that matches the best within the Pilbara and the State.

Finally, the Newman Aquatic Centre continues to be popular as a function centre. There were a large number of Christmas, birthdays and work related functions at the Centre in 2007/08.

During the year, the Shire of East Pilbara also managed the pool at Marble Bar. This facility, operated in conjunction with the Education Department, offered the local community a limited range of activities,

particularly focussed on the children within the town.

Community Events

During the 2007/2008 financial year the Shire of East Pilbara supported many local events including: Fortescue Festival, Policeman's Ball, Carol's by Candlelight, National Tree Planting Day just to name a few. Funding was also provided for events such as the Bloody Slow Cup.

EXHIBITION AND SALES

Cross Country Connecting Communities MMA working with FORM collaboratively other and Aboriginal Art Centres to develop exhibition of painting, fibre work and artefacts about the Canning Stock Route. Meetings to discuss this project have been held Jigalong and Parnngurr at communities.

MMA has been involved in ongoing consultation with Form, AED and Martu artists re: the Cross Country Project. MMA has supported this project in many ways including:

- Canvas stretching
- Materials ordering
- Organisation of supplies for field trips
- MMA's support worker is completing the emerging curators traineeship associated with the exhibition

- A young Martu woman is completing a film and photographic associated with the project
- MMA participated in a painting workshop at CSR Well 36 in August
- Over twenty Martu artists participated in the workshop.
- A workshop was held at Kunawarritji community in April 2008, with 25 artists participating and 15 children.
- Paintings created for this exhibition have been sent to Beijing as the only Australian content at the Olympics Expo.

Summary

In its second year of operations, MMA is now at a vital stage of development. The crucial steps of artists and community engagement have been highly successful, professional staff are managing a best practice operational model and there is significant commercial and artistic interest in the artworks produced.

However significant challenges remain for MMA in continuing to grow the enterprise in ways that meets both artists' aspirations and market demand. The major threats and challenges to MMA stability and future


growth is a complex combination of consistent service delivery, ongoing community relationships, expanding commercialisation and sufficient infrastructure in the communities and the Newman office.

With only one full time staff member, in cramped accommodation there is a direct threat to the stability of such an in-demand service that is attempting to meet the needs of such geographically isolated communities.

MMA has a number of strategies to meet these challenges. The partnership with BHP will boost the regional services, by locating a permanent staff member in Parnngurr, the field officer will service the other communities from the Parnngurr base. MMA has also developed the partnership for the MCDP, this will provide training, mentoring and employment for young Martu arts workers.

MMA recognises the logic of the regional service delivery model under which we operate and the subsequent benefits this model brings to the artists and the wider Martu community in the East Pilbara, however the sustainability of this model is dependant upon resources to match service delivery to 85 artists spread over an enormous geographically isolated area.

TECHNICAL SERVICES









Roadworks



The Shire maintains a road network comprising approximately 3,300 kilometres including 110 km that is sealed. The road network extends from Cape Keraudren (north west of Port Hedland) through to the Northern Territory border.

Townsites:

Newman Shopping Centre carpark was resurfaced and remarked late in the year, and the commencement of the tree planting and landscaping programme. These projects were in conjunction with the East Pilbara sustainability partnership (between Shire of East Pilbara and BHP Billiton Iron).

Resealing works around Newman Townsite included Welsh, Newman, and sections of Kalgan Drives. The completion of the Welsh Drive reconstruction was also completed in 2007-08.

Radio Hill Lookout Road was sealed, with new signage and guideposts to complete the project.

Rural roads:

The continuation of the federally funded Roads to Recovery Program enabled gravel-sheeting works to be undertaken on sections of the Warrawagine Road, Munjina-Roy Hill Road, Jigalong, Shay Gap Road, Balfour Downs Road, and Muccan-Shay

Gap Road. Woodie Woodie Road included a re-seal. The Shire will receive just under \$3 million for expenditure on the Shire's roads. The roads to benefit from the funding are distributed throughout the western third of the Shire from north of Marble Bar through to the Newman townsite. Details of the program can be obtained from the Manager Engineering Services.

Road and drainage improvements were completed on Aboriginal Community Access Roads, Kunawaritji, Talawana, Kiwikurra, Jupiter Wells, and Punmu.



Sportsgrounds, Parks and Reserves

growth in population Newman continued during the year and is expected to continue for several years. The higher population generates increased treated effluent water being available for reticulation on the ovals. The additional water allows greater confidence in the grounds maintenance, however Health Department restrictions on watering times does not allow for uncontrolled day time watering.

Works on the parks, gardens and reserves within the three towns were generally maintenance only with some improvements being made on playground equipment maintenance. Fencing was installed to the boundaries of all the playgrounds in Newman.

The usual flurry of activity occurred during late June at the Marble Bar Sports Complex in preparation for the annual Race Day in July. The Shire continues to support the event through the provision of labour and equipment for track preparation and general preparation work of the buildings and surrounds.

Plant and Equipment Replacement

The Shire has approximately \$7 million of plant and equipment ranging from small lawn mowers through to a 40 tonne bulldozer.

The timely replacement of this equipment is essential to balance operating maintenance costs, together with operating hours versus breakdowns. With annual expenditure on replacement predicted to be around \$2 million over several years, planning commenced to evaluate ways and means of managing the replacement timing and operating costs to ease pressure on the Shire's financial resources. The approach developed was to plan for the refurbishment of appropriate plant and equipment in lieu of replacement in the year due to manage cash flow requirements over the next five years.

Commercial and Domestic Refuse Collection

The program of providing domestic refuse collections of once weekly from April to September and twice weekly from October to April continued in 2007-08 within all three towns. In combination with tip site maintenance, commercial collections and street litter collection (street bins and litter removal), the expenditure for the year was in excess of \$800,000 and income of \$490.000.

In July 2007 the Shire distributed fridge magnets to all households within the three towns providing information on domestic collection days and recycling collection days for Newman.

Council approved the expansion of the recycling collection service for Newman by allowing for the purchase of additional bins. The service remains optional and residents interested in participating should contact the Newman office.

Newman Sewage Treatment Plant

The treatment plant is owned and maintained by the Shire. The facility receives untreated sewage from the Water Corporation deep sewer network and treats it to produce a treated effluent (water). The water is chlorinated and used for reticulating the sportsgrounds and a number of community organisations grassed areas (e.g. Lions Animal Park).

The facility is one of a few mechanical wastewater treatment plants in the State and when first installed by BHP it was designed for a nominal town population of around 9,000.

The Shire receives a financial contribution from Water Corporation and the balance of funds from a levy raised against Newman properties.

The operating expenditure has been increasing with the increase in population and a program of capital improvements has been ongoing to ensure reliability and compliance with environmental and public health licensing requirements.

Airport



The 2007/08 financial year has seen some major changes, investment and growth at the Shire of East Pilbara's Newman Airport.

The resource growth in the region has contributed to a significant growth in numbers passing through passenger Newman. 134,123 passengers travelled in and out of Newman on Regular Passenger Transport (RPT) services in the 12 months to June 30 2008. The majority of these passengers travelled on the Qantaslink services. During the year Qantaslink added additional services to meet growth in passenger demand. Charter services are also on the increase, and during the year a once-weekly charter service Brisbane-Newman commenced, to transport staff for a major mining contractor. Projections on passenger growth indicate Qantaslink add additional services, RPT passengers numbers can be expected to reach 160,000 during the next 12 months. Virgin Blue are also introducing daily services commencing October 21, 2008.

With this growth in activity has seen significant capital investments and upgrades in airport facilities:

 Construction of a brand new passenger terminal facility commenced in June 2008 and completion is anticipated by Christmas 2008, with a move to the new building anticipated for January 2009. The new building will be significantly bigger in size and represents a further \$6.5m in investment in the Newman Airport by the Shire of East Pilbara.

- An expanded apron and new taxiway were constructed during the year to cope with increased traffic and future demand for larger aircraft such as the Boeing 737-800. This project cost \$2m to complete and became operational during May 2008. In addition, the runway was re-sealed in December 2007 and the existing apron and turning nodes were hot-mixed as part of an on-going maintenance programme.
- A new 200KVa standby generator was installed to cope with the increasing power demand at the airport. This unit will provide continuous backup power in the event that the mains supply fails.
- Construction of a new airport equipment shed was also completed to replace the existing shed that was required to be relocated from the area surrounding the apron extension. The new shed is significantly larger and houses the tractor and other machinery.
- Smoothy Helicopters completed construction of a new hangar and office facility.
- Thrifty completed construction of a new rental vehicle facility and office complex for their Newman operations.
- Construction of a new house commenced on the Airport reserve. This house has been planned to allow an onsite staff member to reside in to assist with the daily operations of the airport.
- Landscaping of the access road with grass and the construction of a limestone walled entrance statement was completed during the year. In addition, landscaping of the area between the car

rental offices and the terminal was also completed.

 Development of a new master plan to map the future land use needs and development of Newman Airport has commenced.

Looking forward to 2008/09 the growth and investment in Newman Airport will continue to underline its importance as a key transport link in the rapidly growing Pilbara region.
