## Dangerous & Restricted Dogs

### DECLARED DANGEROUS DOG

Means an individual dog that under section 33E(1) is declared to be a dangerous dog (declared)

### DEFINITION OF RESTRICTED BREEDS

Pit Bull Terrier breed or American Pit Bull Terrier,

Fila Brasileiro (Brazilian fighting dog),

Japanese Tosa,

Dogo Argentino (Argentinian fighting dog),

Perro de presa Canario

### COMMERCIAL SECURITY DOG

Means a dog that is kept primarily for the purpose of guarding or protecting premises that are not dwellings and that are not the premises of the dog's owner, whether or not accompanied by a dog handler.

## Dog Microchipping

### DOG MICROCHIPING

All dogs over the age of three months must have a microchip implanted. The microchip contains a unique identification code that when scanned by a Ranger will lead to identifying your dogs particulars and its owners contact details being available.

In many instances, lost dog's have been reunited with their long lost owner after many months and in some cases, different states.

### Dog owner responsibilities

1. Dogs three months & over must be registered.
2. The Shire must be informed immediately in writing or by email of any change in ownership, the death of the dog & change of address.
3. Proof of sterilisation is needed to claim the concession rate.
4. Proof of certificate of microchipping for all new dog registrations.

### IMPORTANT

Fencing requirement (Section 16 Dog Act) The owner shall provide means on the premises for effectively confining the dog in or at the premises.

Control of Dogs in Public Places (Section 31 Dog Act) A dog shall not be in a public place unless it is (a) held by a person capable of controlling the dog or (b) securely tethered by a leash.
