Copies of Residential Building Plans

The Shire of East Pilbara will where possible provide copies of approved building plans on request.

WHAT DOES THIS SERVICE PROVIDE?

The Shire of East Pilbara Building records are generally complete back to the 1990s, however prior to that time **Not all** records are held by the Shire. With more recent records we can generally provide copies of the following information:

- Building Licence/Permit application
- Plans – Site plan, floor plan and elevations.

WHO CAN REQUEST COPIES OF BUILDING PLANS?

Only the owner is entitled to view or request copies of the Shire of East Pilbara building records. The owner includes the person shown in the Shire of East Pilbara's records as being the owner, a person who is authorised in writing by the owner, or a prospective owner.

The Shire of East Pilbara will require proof of identity, authority and/or a copy of the signed and accepted Offer and Acceptance.

AVAILABILITY

Hard copy and off-site plans will take up to **10 working days** to retrieve and copy. The Shire of East Pilbara will post plans to the applicant as soon as they are available.

APPLICATION FEE

A **non-refundable \$60.00** application fee is required for **each** Building Licence/Permit application request.

You can pay in person or send a cheque or money order.
