1. JUNIOR SPORTSPERSON OF THE YEAR

- a. Must be aged 17 and under as at 31 Oct 2022.
- b. Selected through a formal process and competed at Regional, Country, State, National and/or International Championship program or similar event.
- c. Not been suspended, disciplined, or reprimanded at any level of competition.
- d. Reside within the Shire of East Pilbara LGA.

2. SPORTSMAN OF THE YEAR

- a. Must be aged 18 and over as at 31 Oct 2022.
- b. Selected through a formal process and competed at Regional, Country, State, National and/or International Championship program or similar event.
- c. Not been suspended, disciplined, or reprimanded at any level of competition.
- d. Reside within the Shire of East Pilbara LGA.

3. SPORTING GROUP OF THE YEAR

- a. Base of Operations or Clubhouse located within the Shire of East Pilbara LGA.
- b. Club has participated in Club Development Program workshops in 2022 calendar year.
- c. Has maintained or increased membership numbers from previous year.
- d. Appropriate levels of 'best practice' surrounding club governance and management are evident.
- e. Club can demonstrate sound financial management.

4. UMPIRE/OFFICIAL OF THE YEAR

- a. Officiated at sporting fixtures/events within the Shire of East Pilbara LGA in 2022.
