ELIGIBILITY

- Must be a property owner **in the East Pilbara**
- Must **live in the property** that they own
- Maximum of **\$200 per property**.
- Must provide **proof of address** (driver's licence and bill) plus **Rates Notice**.
- A property owned in the **name of a company** is **NOT** eligible.

CONDITIONS

1. If multiple property owners are eligible, all owners must sign the application form, and ID of those owners must be provided. Owners to confirm relevant bank details for the transfer.
2. The owner/s of each property is eligible to receive \$200 once for the 2025/26 Rate year.
3. Period of eligibility is between 1 August 2025 – 30 June 2026.
