#### REPORT PURPOSE

The purpose of this report is for Council to consider accepting grant funds to the value of \$950,000.00 (excl GST) to be expended over three years for the purpose of funding the delivery of the 'East Newman Revitalisation and Sustainability Project', and making a consequential budget amendment.

# **BACKGROUND**

In 2020, Nyiyaparli and Martu came together to sign the 'This is Our Dream Cultural Compact' and invited others to listen, follow and join their story. The Cultural Compact was a commitment to laying down new foundations to walk together in a new way with others. The East Newman Precinct Structure Plan (ENPSP) was one of the projects resulting from the Cultural Compact. The ENPSP aims to create a thriving community in East Newman by establishing key priorities that will allow for better opportunities in healthcare, housing, education and cultural wellbeing. The ENPSP specifically seeks upgrades to public open spaces and parks, and improved connections throughout the area, including:

- Upgrades to streets, ensuring safety and comfort through landscaping and increased tree canopy.
- Redeveloping streets to provide increased connection creates an opportunity for passive surveillance, reducing anti-social behaviour.
- Upgrades to community spaces like parks and streetscapes to connect the community.

In 2024, in line with ENPSP, the Shire of East Pilbara ("the Shire"), BHP Community representatives and the BHP Non Processing Infrastructure (NPI) representative created three working groups to address a variety of concerns across East Newman. The East Newman Revitalisation and Sustainability Project (ENRS) is a collective approach to fund the outcomes of two of the Revitalisation Working Group and Asset Sustainability Working Group.

This ENRS project will address revitalisation and liveability needs of the residents living in East Newman. The ENRS seeks to address needs for greening, tree planting, streetscaping, street clean-up initiatives, lighting, security and access measures. The outcomes from the project seeks to address issues to mitigate anti-social behaviour, remove or refurbish broken structures, including but not limited to bus stops, shade structures, and public art.

This ENRS project will fund the ENRS Working Group actions that fall outside of the normal maintenance scope of the Shire or BHP NPI standard work schedules. The ENRS Working Group will also update the East Newman asset register for public facing structures and establish an agreement with respect to who will take responsibility for ongoing maintenance following the completion of work.

Commencement: 01/04/2024 Completion: 31/10/2025

# **COMMENTS/OPTIONS/DISCUSSIONS**

The Shire seeks to accept \$950,000.00 (excl GST) from BHP to action key works over 18 months (FY 2023/24, 2024/25 and 2025/26) identified as part of the East Newman Revitalisation and Sustainability Project.

The project is expected to include increased greening and tree planting, streetscaping in East Newman, clean-up initiatives, and additional lighting and security measures. It will also improve the safety of selected thoroughfares and remove or refurbish broken

Significant investment is required to address all priorities within the ENPSP. Therefore, the initial pilot program will operate as a demonstration project, focusing on the intersection of Niminigarra Drive and Armstrong Way. Additionally, the ENRS project will target streetscapes at the beginning of Armstrong Way and extend to the alleyway between Knox Way and Armstrong Way, Newman.
