Notice of the following question was given by Cr Wendy McWhirter-Brooks on 24 March 2025.

I would like a response to DFES declaring that the Evacuation Centre's in Nullagine and Marble Bar were not fit for purpose and as a result the community needed to shelter in place. What is being done about Evacuation Centre's in Nullagine and Marble Bar?

Administration Response

The Nullagine Evacuation Centre is the School and is managed by the Department of Education. The Marble Bar Evacuation Centre is the Civic Centre managed by the Shire. Both were audited by the Dept of Communities late last year with no issues reported.

Nullagine and Marble Bar Evacuation Centre's were used during Tropical Cyclone Ilsa with no issues reported.

During Tropical Cyclone Zelia the new DFES Divisional Commander advised they were not happy that the Marble Bar Civic Centre has exposed windows and decided, against the advice of the Incident Controller, to not stand up the Evacuation Centre.

The Shire is installing severity screens on the windows, with a contractor onsite yesterday for final measurement of the windows in Marble Bar prior to installation before the end of this financial year. The Shire is not aware of complaints regarding the Nullagine Evacuation Centre. Shire staff will follow up at next week's Local Emergency Management Committee Meeting.
