This Permit is for the purpose of "Essential Services Only" and applies for the purposes issued and vehicles listed only and subject to the following conditions:

- This permit is valid from the day of issue until Monday 12 January 2026. The permit holder shall monitor rainfall in the area of proposed travel. If rain is received in the 12 hours preceding the proposed travel, the permit is invalid. The permit may be revoked at any time subject to weather / road conditions.
- Travel shall be in daylight hours only.
- No responsibility will be accepted by the Shire of East Pilbara for any personal injury, bogged, disabled or damaged vehicles or any other loss howsoever arising from use of the road whilst closed. Any bogged or disabled vehicle is not to be recovered until the condition of the road pavement enables recovery without damage to the road and or drainage system.
- The permit holder indemnifies the Shire against any claim for vehicle damage, or any other loss arising howsoever from use of the road when closed to public traffic.
- Damage caused to the roads if used during unsuitable conditions may be debited to the vehicle owner, depending upon the circumstances.
- Use of the road is to be kept to a minimum.
- Extreme caution is required when travelling on the road especially at creek crossings where dead slow is the recommended requirement and care must be taken due to scouring of the road.
- Report any damage to the road or unsafe areas to the Shire of East Pilbara

This Permit is conditional upon observance of the Road Traffic Act of WA, Statutory Speed Limits and all warning signs that may be displayed. Driver vigilance must be maintained for obstruction and prevailing road conditions. During periods of heavy rain, some sections of the road may be subject to **FLASH FLOODING** and **WASHOUTS**. **Do not drive into water of unknown depth and velocity.**
