

SHIRE OF EAST PILBARA

SMALL SCALE HOME BUSINESS

In residential areas a Small Scale Home Based Business operating incidentally to the residential use of land by the resident (occupier) of a property is allowed. As these businesses can vary in size, scale and nature they will have consequently varying impacts on the neighbourhood.

Types of Home Businesses

Town Planning Scheme No 4 provides for the following types of Home Businesses

- Home Office
- Home Occupation
- Home Based Business

Each of these business types may occupy different amounts of space and has different requirements. These requirements are listed on the following page.

Basic Requirements

A Home Business shall:

- Only be carried out by an occupier of a dwelling.
- Not be transferable to any subsequent owner or occupier or another property.
- Not require the provision of any service of a greater capacity than normally required for the residential use of the land;
- Not affect the amenity of the neighbourhood because of signage, waste, parking, noise, deliveries, numbers of customers, hours of operation etc.
- Not be an inappropriate use in the residential area.
- Have adequate parking provision for clients in addition to the 2 residential parking spaces and not disrupting access to those spaces.
- Not entail the retail sale, display or hire of goods or the storage of meats, fish, vegetables or fruit

Applications

When seeking an approval from the Council it will be necessary to address each of the various issues listed above. If, in the opinion of the Council, a home occupation is causing a nuisance or annoyance to owners or occupiers of land in the neighbourhood the Council may revoke its approval.

Other Approvals

Some Home Occupation activities will require an additional "Health" or other approval prior to the use commencing which can be obtained from the Shire of East Pilbara Health Services on 9175 8000 or other agencies as listed.

These include:

- Conducting swimming lessons in a private swimming pool.
- Hairdresser or skin penetration premises, including hairdressing, waxing, electrolysis, tattooing, acupuncture, ear or body piercing, manicure or pedicure, permanent eyebrow or lip lining and shaving.
- The preparation of food for consumption by others
- Family Day Care Centres. Please contact the Department of Community Development.
